GENERAL CLARIFICATIONS

- A. Bid items with 0 quantities have been deleted from document 330 and the electronic bid tab. Updated versions of Document 330 and the electronic bid tab are included in this addendum.
- B. The existing Flygt pumps for Pump Station 53 shall be used for the new pump station. The bid item “pump station in place” for Pump Station 53 shall not include submersible pumps. However, it shall include any necessary equipment needed to ensure the existing pumps will work with the rehabilitated pump station. Contractor shall provide new standard guide rails and pump base for the existing pumps as part of the equipment provided for the new pump station.

 - a. The Pump Station, In Place bid item for PS 53 shall not include new pumps. The contractor shall reuse the existing pumps for PS 53. Contractor shall supply all equipment to ensure existing pumps will be compatible with rehabilitated pump station and new equipment. Contractor shall provide new standard guide rails and pump base for the existing pumps as part of the equipment provided for the new pump station.

B. Section 262923 Variable Frequency Motor Controllers

1. Part 2, Section 2.02, Subsection F 7: change Ambient Temperature Rating to "Not less than 0 deg F and not exceeding 122 deg F.

C. Section 333219 Public Utility Wastewater Pumping Stations

1. Part 2, Section 2.03, Subsection D: add the following Paragraph 2. After Paragraph 1.
 - a All VFDs shall be 50 deg C (122 deg F) rated VFDs.
2. Part 2, Section 2.03, Subsection B: Delete paragraph 4 in its entirety. Renumber subsequent paragraphs accordingly.

1. Add the following General Note 7 after General Note 6:
 - a FOR PS 53, THE CONTRACTOR SHALL REUSE THE EXISTING PUMPS FOR THE REHABILITATED STATION. CONTRACTOR SHALL SUPPLY ALL NECESSARY EQUIPMENT TO ENSURE EXISTING PUMPS WILL BE COMPATIBLE WITH REHABILITATED PUMP STATION AND NEW EQUIPMENT. CONTRACTOR SHALL PROVIDE NEW STANDARD GUIDE RAILS AND PUMP BASE FOR THE EXISTING PUMPS AS PART OF THE EQUIPMENT PROVIDED FOR THE NEW PUMP STATION.

b. Bidder has familiarized itself with the nature and extent of the Contract Documents, Work, site, locality, and all local conditions and Laws and Regulations that in any manner may affect cost, progress, performance or furnishing of the Work.
